## INSTRUCTIONS.

### General.

1.—This Register must be produced whenever required by any of H.M. Inspectors of Factories and Workshops, or by the Certifying Surgeon and, when no longer used, must be kept for at least two years after the date of the last entry.

2.—Any entry made by the Occupier or on his behalf is, as against him, *primâ facie* evidence of the facts therein stated; and failure to make any entry with respect to the observance of any provision of the Factory and Workshop Acts is *primâ facie* evidence that the provision has not been observed.

### Registration.

3.—The Occupier must enter in columns 2 to 8 of Part II. particulars of all young persons employed\*, and in the case of a factory or of a workshop to which this requirement extends (see Abstract) the certificates of fitness (columns 9 to 13) must be obtained from the Certifying Surgeon, as follows:—

### Certificates of Fitness.

4.—A Young Person under Sixteen must not be employed in a factory, or in such workshop as aforesaid, for more than seven (or if the Certifying Surgeon resides more than three miles therefrom, thirteen) work days without a certificate of fitness for employment therein. This certificate can only be given by the Certifying Surgeon for the District, and by means of signed entry in the General Register.† He cannot grant it except after personal examination; nor elsewhere than at the Works, unless fewer than five *young persons and children* are employed there. The certificate may be qualified by conditions as to the work on which the young person is fit to be employed. When a child becomes a young person a fresh certificate of fitness, for full time employment, must be obtained.

### Educational Certificates for Young Persons under 14.

5.—A child who has reached the age of thirteen, and has obtained a certificate from the local School Authority qualifying for full time employment‡, is regarded as a young person. The certificate must be kept by the Occupier, and the date entered in Column 7 of Part II.

\* "A woman, young person or child who works in a factory or workshop, whether for wages or not, either in a manufacturing process or handicraft, or in cleaning any part of the factory or workshop used for any manufacturing process or handicraft, or in cleaning or oiling any part of the machinery, or in any other kind of work whatsoever incidental to or connected with the manufacturing process or handicraft, or connected with the article made or otherwise the subject of the manufacturing process or handicraft therein, shall, save as is otherwise provided by this Act, be deemed to be employed therein within the meaning of this Act. For the purposes of this Act an apprentice shall be deemed to work for hire." (S. 152, Act of 1901).

† The Certificate may, if the Certifying Surgeon thinks fit, name all the works within his district which are in the occupation of the same occupier. In this case a separate form of certificate (supplied by the Certifying Surgeon) is required, and must be attached to the General Register of the works in which the young person is, for the time being, employed. The number and date of the Certificate, and the name of the Certifying Surgeon, must be entered in Col. 11 of the Register.

‡ In districts where the Education Bye-Laws apply to children between thirteen and fourteen, a child of that age cannot be employed full time unless he has satisfied the conditions prescribed by the Bye-laws (of the district in which he resides) for total exemption. In Scotland young persons under seventeen may be required to attend continuation classes, and any time so spent must be deducted from the period of employment.
