Staff matters

London School of Economics

The Treasurer referred to letter which had been addressed to Chairmen of Railway Companies by the London School of Economics and submitted particulars of the number of Underground Employees attending the

School as students pointing out that the Undergraduate Companies contributed \$100 to the funds of the School in respect of 148 students

The Chairman stated that collective action should be taken by all Railway Companies to increase the amount of subscriptions to the School and that our Companies would be willing to fall in line with any arrangements made by other Railway Companies.

The Operating Manager submitted letter which had been addressed to the Accountant of the Midland Railway on this matter, which was approved.

177 "K" Type Bus

The Manager for Maintenance (L.G.O.) reported that 15 "K" Type chassis had been delivered to the Coach Factory, 9 of which were being mounted and two would be set aside for training purposes at Milmans Street depot.

The Chairman added that he considered the output from Walthamstow would shortly be increased and the L.G.O. Company might expect to receive deliveries of 25 chassis per week.

Single Deck Omnibuses

Referring to Minute No 2940 of the Executive Officers' Meeting held on 20th April 1920.

Drawings were submitted with suggested reseating arrangements shown thereon. After discussion, authority was given for one body providing seats for 33 passengers to be constructed for experimental purposes.
