3524 Read Minutes of Meeting on 12th inst. - the same were confirmed.

3525 *General Meeting - Mess. Vacossin & Laurat deputed to represent Paris Directors.*

Read Minutes of Meeting of the Paris Committee on 17th inst. deputing Mess. Vacossin and Laurat to represent them at the General Meeting of Shareholders on 24th inst.

3526 Read Minutes of Meeting of Accounts and Finance Committee on 18th inst. the same were confirmed and adopted.

3527 *Inland Revenue Penalty – one half to be charged to Northern District - party in fault to pay full amount in future*

Read Minutes of Meeting of Works Stores and Traffic Committee on 18th inst. the same were confirmed and adopted. Resolved in reference to Minute No. 1341 that one half the penalty be charged to the Northern District with authority to Mr Wilson to levy the amount on the party really in fault in the matter, and that in any similar case in future the full amount of the penalty be required.

3528 Read Statement of Horses and Provender purchased and Horses sold during week ending 14th inst. It appeared therefrom that the Company possessed 7167 horses at that time, that the number owned by them at the corresponding period of 1861 was 6562, that during the week none were purchased - that the purchases in the corresponding week of 1861 were 19 for £528, that 11 Carcases were sold for £19,, 12,, 6 and 4 living horses for £22,, 15,, 0, that 2650 qrs [quarters] of Oats at £1,, 3,, 6¾, 206 qrs of Maize at £1,, 12,, 1½, 94½ qrs of Beans at £1,, 19,, 6½, 200 qrs of Barley at £1,, 7,, 6, 230 loads of Hay and Clover at £4,, 3,, 7 and 95¼ loads of Straw at £1,, 17,, 2¼ were purchased - that the prices in the corresponding week of 1861 were for Oats proportionate to their weight £1,, 2,, 9, for Hay and Clover £4,, 10,, 9½ and for Straw £1,, 9,,

11 ¼ yielding by comparison of the three items a difference equal to £129 against the current year on the average weekly consumption of the Company.

3529 *Gribble's claim - settled for £13,, 13,, 0*

The Secretary reported that the claim of Mr Gribble referred to in Minute No. 3522 of last Meeting had been settled by the payment of £13,, 13,, 0 including costs – the same was approved.
